TERMS AND CONDITIONS RELATING TO DEBIT CARD SERVICES

Person having individual and or joint account /s, with Gurkhas Finance Limited (hereafter referred to as the GUFL) may avail Debit Card/s subject to the following terms and conditions:

1. The card means here the GUFL "ATM" Automated Teller Machine Debit Card.
2. The card is the property of the GUFL.
3. The card is not transferable.
4. Card is only for cash withdrawal, balance inquiry and printing mini statement.
5. The ATM maybe utilized by the Cardholder using the card personal identification number (PIN) issued by GUFL.
6. Cardholder acknowledges that use of a PIN provided him/her a commercially reasonable degree or protection in light of their particular needs and circumstances. GUFL assumes duty to discover any breach of security by Cardholder or the unauthorized disclosures or use of PIN. Except as otherwise provided by law, GUFL is not responsible in any way for the manner in which the card is utilized.
7. The card must be signed immediately upon receipt by the card holder. The card remain the property of GUFL and must be surrendered to GUFL upon demand.
8. If the information submitted by the Cardholder is found false and or the card has been misused, GUFL reserves the right to seize/cancel the card issued to any Cardholder.
9. Usage of the card will be limited to debit only. No electronics (ATM) deposit may be made using the card. GUFL may from time to time change/amend/add no facilities in the card and such the usage of the card may go beyond debits in such case(s).
10. The card and the PIN number shall be issued to the Cardholder at his/her risk and responsibility. It is recommended that the Cardholder changes his/her PIN at the first usage of the card. The Cardholder undertakes not to pass the card or disclose the PIN to any other person.
11. The GUFL shall debit the designated account of the Cardholder for all transaction initiated including cash withdrawal by using card. For this purpose the Cardholder irrevocably authorizes the GUFL to debit his/her designated account affected through the use of his/her card.
12. Cash from ATM will be dispensed only in Nepalese Rupees in 500 and 1000 denomination or in such other denominations as, decided by GUFL minimum of NPR 500 and maximum of NPR. 16,000 maybe withdrawn from ATM per transaction. Card may be used in the ATM to withdrawn money up to 5 times a day & per day transaction limit upto NPR 50,000/-.
13. The Cardholder shall provide written instructions to the GUFL for the cancellation/non-renewal of the card one month prior to the expiry date specified in the card.
14. The Cardholder agree to inform GUFL in writing regarding lost/stolen, damage of the card and disclosure of PIN. The Cardholder held liable for all transactions received prior to this notification.
15. GUFL reserves the right to terminate membership, withdrawal the privileges attached to the card or not renew the expiry date specified in the card.
16. GUFL reserves the right to amend these terms and conditions along with fees and charges without prior notice to the Cardholder and such amendments shall be binding the Cardholder.
17. All disputes are subjected to the jurisdiction of courts in Kathmandu, Nepal.
